TREASURER'S REPORT

2016-17 in Review

- Full presentation of past year's financial results will be given at the Semi-Annual Meeting; this is an overview and highlights only
- Total givings of \$323,787, almost \$10,000 below budget
- Expenses lower than budgeted mainly due to Rob's sabbatical; fewer social and fellowship events; savings on supplies, resources and curriculum
- Building & Renovation Fund donations for the year were \$23,296
- Benevolent Fund donations for the year were \$11,675
