Overview of Responsibilities

- Present a proposed Joint Venture Agreement between UBC and HM for congregational approval at the May 2018 AGM
- Engage with HM to develop an agreement that is "Win-Win" for both organizations over the long term
- Engage with the UBC congregation to ensure that our long-term goals can be fulfilled
